
First Author	Year	Definition
Koopmans [30]	1993	"Social movements are characterized by a low degree of institutionalism, high heterogeneity, a lack of clearly defined boundaries and decision-making structures, a volatility matched by few other social phenomena." (p.637).
Elsey [16]	1998	A voluntary banding of concerned people is characterized by the efforts of many committed individuals and groups. Social movements are motivated by strong interests and beliefs that are channeled into social and political action.
della Porta [31]	1999	"Informal networks, based on shared beliefs and solidarity, which mobilise about conflictual issues, through the frequent use of various forms of protest." (p.16)
Morris [32]	1999	"As a form of collective behavior, social movements were considered spontaneous, unorganized, and unstructured phenomena that were discontinuous with institutional and organizational behavior" (p.531).
Parkinson [33]	2000	A group of people organized, outside of institutions established for this purpose, to bring about political and social change which will satisfy their shared interest or goal.
Bibby [17]	2009	"A voluntary collective of individuals committed to promoting or resisting change through coordinated activity. They produce a lasting and self-generating effect and create, as they do this, a sense of shared identity." (p.25)
Herechuk [34]	2010	"A manifestation of people's passions for a common cause. Social movement's theorysheds light on the passionate engagement that people bring to a common cause." (p.148)

Bell [35]	2014	A large number of people who act together to pursue some shared objective.
del Castillo [36]	2016	"A health social movement is a persevering people-powered effort to promote or resist change in the experience of health or the systems that shape it." (p.23) "social movements are innovators, forms of democratized engagement, community and resource mobilizers, knowledge produces, awareness raisers and conversations starters, empowerment builders, change accelerators, power redistributors, relationship builders, and diffusers of new ideologies." (p.23 – 24)
Tremblay [37]	2018	Large group actions that promote social change that seek to reverse unequal relations of power by creating broad social, political, or systemic changes.
