The study was performed with 40 mice (20 females and 20 males), allocated in two experimental groups as outlined in Figure 1 and Supplementary Figure 1.  
Sample size were chosen based on numbers used in similar studies. No power calculations were performed in advance.

All reported results were determined based on two different sequencing batches. Additionally, for each experimental group within each batch, males and females were splitted into separated cages (n=5 animals per cage).

### Randomization

Animals were randomly allocated in experimental groups (immunized and mock) and separated in different cages by sex (n=5 mice per cage).

### Blinding

This was an exploratory study, and as such, there was no treatment group requiring blinding, outside of / apart from the randomization of sub-samples for statistical tests.
