## Life sciences study design

Sample size	Sample sizes were not pre-determined. A total of 4,730,447,888 clones across 2,130 repertoires from multiple studies with COVID-19 and healthy donor TCR sequencing data available at the time this study was initiated were used for analysis.
Data exclusions	Only repertoires that were unable to be processed using Immunarch were excluded from analyses.
Replication	For sequence and motif analyses, statistics and metrics were determined by dataset to ensure reproducibility of findings. For ML training and evaluation, partitioning and cross-validations were repeated 100 times per permutation to ensure reproducibility of model performance.
Randomization	All the samples in the dataset were independent and non-repeating samples. We allocated samples for training the ML models using a stratified k-fold strategy with randomization for training and testing set splitting.
Blinding	Since human patient samples were not used for this study, and group allocations for training were performed automatically (by randomization), blinding was not necessary for this study.
