Sample size	A minimum of three biological replicates were chosen for all transformation or editing assays in this study following standard practices in molecular biology and microbiology. To evaluate editing efficiencies, individual transformants were screened for each condition (three individual transformants for the non-targeting samples and ten individual transformants for the targeting samples). One biological replicate was screened for each strain for the northern blotting analysis. One edited and unedited K. pneumoniae colony was used to evaluate resistance to beta lactamase through transformation with a plasmid or water. From those transformants, three colonies of each edited sample were screened whether the plasmid was maintained. All corresponding information can be found in the associated figure legends.
Data exclusions	No data were excluded from analyses.
Replication	Biological replicates were based on starting from separate colonies or repeating blotting experiments with separately isolated RNA. All replicate experiments were successful.
Randomization	Colonies were picked at random for screening. No other randomization was employed, in line with standard practices in molecular biology and microbiology.
Blinding	Blinding was not relevant to the study because all samples (targeting and non-targeting) were subjected to the same screening methods. Therefore, knowing which sample is which would not impact the outcome.
