This is a proof-of-principle study and therefore, our findings are on the potential of our method and we do not generalize over populations. Despite working with precious human post-mortem material, we conducted the study with a minimal sample size of 2 for both brain tissue as well as prostate tissue samples to allow for one internal replication round. Update: For additional work for the revised manuscript we have used additional samples. In total we used human occipital lobe samples from 3 human body and 3 prostate cancer samples.
